## **About the Authors**

Pirmin Stekeler-Weithofer is Professor of Philosophy at the University of Leipzig. He specializes in the philosophy of language, logic, mathematics and the history of metaphysics. He is the author of *Grundprobleme der Logik* (1986), *Hegels Analytische Philosophie* (1992), *Sinnkriterien* (1995), *Was heißt denken?* (2004), *Sprachphilosophie* (2005), *Formen der Anschauung* (2008). He is the editor and co-editor of philosophical journals, handbooks and readers like *Philosophische Rundschau; Philosophisches Jahrbuch; Enzyklopädie Philosophie* (1998); *Geschichte der Philosophie in Text und Darstellung* (2004), and *Grundfragen der Philosophie* (Berlin).

Jaroslav Peregrin is Professor at the Institute of Philosophy of the Academy of Sciences of the Czech Republic and the head of the Department of Logic of the Philosophical Falulty of the Charles University. His main areas of interest are the philosophy of logic, analytic philosophy, and semantics. He is the author of *Doing Worlds with Words* (1995) and of *Meaning and Structure* (2002). He has written articles in *Erkenntnis, Journal of Philosophical Logic*, etc.
