

Thematic patterns are not optional stylistic variants; they are integral part of the meaning of language. Texture is not something that is achieved superimposing an appropriate text form on pre-existing ideational content. The textual component is a component of meaning along with ideational and interpersonal components [...]. The system does not first generate a representation of reality, then encode it as a speech act, and finally recode it as a text [...]. It embodies all these types of meanings in simultaneous networks of options, from each of which derive structures that are mapped onto one another in the course of their lexico-grammatical realization.
