

## Notes on contributors

Anders Ahlqvist received his PhD in Celtic Studies from Edinburgh University in 1974. In 1976, he became a Statutory Lecturer of Old and Middle Irish at University College, Galway; in 1993 he was promoted Associate Professor at the same University, which later became the National University of Ireland, Galway; he retired from it as a Personal Professor in 2005. In 2008, he was appointed Foundation Sir Warwick Fairfax Professor of Celtic Studies at the University of Sydney, retiring and becoming an Honorary Professor in 2013. Since 2005 he has chaired the Governing Board of the School of Celtic Studies in the Dublin Institute for Advanced Studies.

Elizabeth Boyle is a lecturer in Early Irish at Maynooth University. Her research interests include the intellectual, cultural and religious history of early medieval Ireland.

**Liam Breatnach** is a Senior Professor at the School of Celtic Studies, Dublin Institute for Advanced Studies, and co-editor of the journal *Ériu*, published annually by the Royal Irish Academy. His research interests include Old Irish language, Middle Irish and the historical development of Irish, Early Irish law texts, and poets, poetry and metrics.

**Thomas Charles-Edwards** was formerly Jesus Professor of Celtic at the University of Oxford. He is the author of *Early Christian Ireland* (Cambridge, 2000) and *Wales and the Britons*, 350–1064 (Oxford, 2013), and has published widely in the fields of medieval Irish and Welsh history and law.

Deborah Hayden is a lecturer in Early Irish at Maynooth University, and previously held postdoctoral research fellowships at the Dublin Institute for Advanced Studies and Christ Church, University of Oxford. Her research interests centre on medieval Irish, Welsh and Latin language and literature, in particular the history of linguistic thought, early Irish and Welsh law and medieval medicine.

Pierre-Yves Lambert has specialized in the linguistic analysis of older Celtic languages, worked on the etymological lexicon of Old Irish and on the Corpus of Gaulish inscriptions, and written an introduction to Gaulish grammar and epigraphy. He is now Emeritus "directeur de recherches" attached to a CNRS laboratory in Paris, "AOROC (Archéologie et philologie d'Orient et d'Occident)".

Ann Parry Owen is a Reader at the University of Wales Centre for Advanced Welsh and Celtic Studies in Aberystwyth. She is the general editor of the University of Wales's Beirdd yr Uchelwyr/Poets of the Nobility Series and the leader of the Centre's Guto'r Glyn Project.

Erich Poppe is Professor of Celtic Studies at the University of Marburg (Germany). His research interests include the history of Celtic Studies in the nineteenth and twentieth centuries; medieval Irish ideas about language and grammar; medieval Irish and Welsh literary history; the adaptation and translation of Continental texts in medieval Ireland and Wales; Middle Welsh syntax.

Paul Russell is Professor of Celtic in the Department of Anglo-Saxon, Norse and Celtic in Cambridge. His research interests include learned texts in Celtic languages (especially early Irish glossaries), Celtic philology and linguistics, early Welsh orthography, Middle Welsh translation texts, grammatical texts, and medieval Welsh law.
