This book grew out of a fascination with the complexity and richness of medieval Japan instilled in me during my graduate studies and fostered by wonderful teachers. To Jeffrey Mass, I owe my interest in Minamoto Yoritomo, so important a historical figure and yet so elusive in the narratives that I work with as a student of literature.
