Guy Attewell, formerly of the Wellcome Trust Centre for the History of Medicine at University College London, has since 2010 been a researcher in the Department of Social Sciences of the French Institute of Pondicherry. His publications include *Refiguring Unani Tibb: Plural Healing in Late Colonial India* (Hyderabad: Orient Blackswan, 2007).

Patrizia Bassini obtained a doctorate from the Institute of Social and Cultural Anthropology, University of Oxford, for a study of home-based medicine on the Sino-Tibetan frontier. She held an OUP John Fell Fund post-doctoral fellowship before returning to live in Amdo-Tibet, where she currently works with NGOs.

Barbara Duden held a chair in the Institute for Sociology and Social Psychology in the Leibniz University Hannover where she taught from 1997 until her retirement. Among her numerous publications is *The Woman beneath the Skin: A Doctor's Patients in Eighteenth-Century Germany* (Cambridge, MA: Harvard University Press, 1991).

Peregrine Horden is Professor of Medieval History at Royal Holloway, University of London, and an Extraordinary Research Fellow of All Souls College, Oxford. He is co-author, with Nicholas Purcell, of *The Corrupting Sea* (Malden, MA: Blackwell, 2000), and is at work on its sequel. He also writes on the history of charity and medicine. His recent publications include *Hospitals and Healing from Antiquity to the Later Middle Ages* (Aldershot: Ashgate, 2008), and he is preparing a general book on early hospitals for Yale University Press.



Elisabeth Hsu is Professor of Anthropology at the Institute of Social and Cultural Anthropology of the University of Oxford, and Fellow of Green Templeton College. Recent co-edited volumes include: *Wind, Life, Health* (Oxford: Blackwell, 2008), with Chris Low, and *Plants, Health and Healing* (New York: Berghahn, 2010), with Stephen Harris. Her most recent authored book is *Pulse Diagnosis in Early Chinese Medicine: The Telling Touch* (Cambridge: Cambridge University Press, 2010).

Peter Murray Jones is Fellow and Librarian of King's College, Cambridge. He has published extensively on medieval medicine and science, image-making in medicine, medical books and the circulation of medical information. His books include *Medieval Medicine in Illuminated Manuscripts* (London: The British Library, 1998).

Helen King is Professor of Classical Studies in the Faculty of Arts of the Open University and Visiting Professor at the Peninsula Medical and Dental School. She has written extensively on the history of ancient and early modern medicine. Her books include *The Disease of Virgins: Green-Sickness, Chlorosis and the Problems of Puberty* (London: Routledge, 2003), and *Midwifery, Obstetrics and the Rise of Gynaecology* (Aldershot: Ashgate, 2007).

Shigehisa Kuriyama is Reischauer Institute Professor of Cultural History at Harvard University, where he is a faculty member in the departments of East Asian Languages and Civilizations and of the History of Science. His prize-winning monograph is *The Expressiveness of the Body and the Divergence of Greek and Chinese Medicine*, pbk edn (New York: Zone Books, 2002).

Ellen Messer is Visiting Associate Professor in the Friedman School of Nutrition Science and Policy, Tufts University. She has written extensively on cross-cultural perspectives on the human right to food; biocultural determinants of food and nutrition intake; sustainable food systems (with special emphasis on the roles of NGOs); the impacts of agrobiotechnology on hunger; and the cultural history of nutrition, agriculture, and food science.

David Parkin is Professor Emeritus of Social Anthropology in the University of Oxford. His many books include the monograph *The Sacred Void: Spatial Images of Work and Ritual among the Giriama of Kenya* (Cambridge: Cambridge University Press, 1991), and *Holistic Anthropology: Convergences and Emergences* (Oxford: Berghahn, 2007), co-edited with Stanley Uljaszek.

Emilie Savage-Smith recently retired as Professor of the History of Islamic Science at the University of Oxford and is an authority on the history of medieval Islamic medicine, magic, scientific instruments and cartography. Her recent books include *A New Catalogue of Arabic Manuscripts in the Bodleian Library, University of Oxford*, vol. 1: *Medicine* (Oxford: Oxford University Press, 2011), and *Medieval Views of the Cosmos*, co-authored with Evelyn Edson (Oxford: Bodleian Library, 2004).

Francis Zimmermann is Professor of South Asian anthropology at the École des Hautes Études en Sciences Sociales, Paris. He has published widely on Ayurveda. His books include *The Jungle and the Aroma of Meats: An Ecological Theme in Hindu Medicine* (Berkeley: University of California Press, 1987), *Le Discours des remèdes au pays des épices* (Paris: Payot, 1989), and *Généalogie des médecines douces. De l'Inde à l'Occident* (Paris: PUF, 1995).
