## **PREFACE**

The preparation of this book has taken twenty-five years, during which time I have incurred obligations far beyond what I can acknowledge adequately. Collecting the photographs, on which all our work has been based, was a joint venture by all the members of the Regesta committee. Without this collaboration, in which I personally played a comparatively small part, the task could never have been completed. We received a great deal of practical help at that stage from the late Professor W. Croft Dickinson, and from Professor E. L. G. Stones, who successively acted as general advisers to the committee. Since moving to England, I have been dependent on friends in Scotland to answer questions and check points which I could not verify myself; especially on Dr Ian Rae of the National Library, and Dr Athol Murray of the Scottish Record Office. Both have taken great trouble to clear up problems which they could well have expected a researcher to solve for himself; as well as keeping me informed about the many movements of documents that have occurred since I originally saw them. David and Mairi Robinson have given me hospitality on numerous occasions, making my visits to Scotland even more pleasurable than they would otherwise have been. Dr Grant Simpson and Professor A.A.M. Duncan have always been ready to discuss problems and difficulties; and both have read drafts of the introduction. I have gained much from their comments and suspect that where I have remained obdurate, the loss is mine. Professor G.W.S. Barrow, Professor E. L. G. Stones and Mrs Jeanne Stones have all read the proofs, and not only detected errors that I had missed, but suggested numerous improvements. Professor Barrow has also identified many place-names that defeated me. The staff of Edinburgh University Press. and in particular Miss P.K. Duncan and Mr A.R. Woods, have been meticulous and considerate to a wayward editor; and Mr A. R. Turnbull, the Secretary, has throughout been patient and encouraging. To him the whole project, and not just my volume, owes a very great deal.

Many of my friends have made contributions which I am very happy to acknowledge: Professor R. J. Adam, Mr A. J. Aitken, Hr Nils G. Bartholdy, Mr J. K. Bates, Professor A. L.
