This book is the outcome of a lengthy multicountry research program involving several phases of extended fieldwork at what is often called the “end of the world.” It was very costly for a graduate student living in New York City with limited resources, and I have accumulated more debts than I am able to acknowledge. I am keen and eager to extend my sincerest gratitude and appreciation to a long list of Falkland Islanders who welcomed me into the fabric of their tight-knit community. However, in order to protect the rights of my interlocutors, I have withheld names of individuals from this book. In keeping with conventions of my field, I have used pseudonyms for living participants, apart from select public figures and published authors. Islanders who read this book will likely recognize themselves or their friends and neighbors, and the absence of names is not meant to deceive them. A layer of anonymity will hopefully protect individuals from identification by outside readers who may not already know their identities. In addition to a vast number of individuals who engaged with my research in the islands, I am especially thankful for the institutional support of the South Atlantic Environmental Research Institute (SAERI), which allowed a qualitative social scientist to rub shoulders, and even penguin feathers, with a brilliant cohort of marine ecologists. On my last day in the Falklands, which also happened to be my birthday, a fisheries scientist hosted a barbecue with friends and acquaintances. There, SAERI researchers and friends set up balloons, baked a cake, and surprised me with gifts showing that they had listened closely to me and engaged with my research. I was touched by SAERI's warm embrace, and I remain very grateful for their hospitality. I also had the privilege of inher-

iting well-organized stacks of colonial letter books, reports, and periodicals from the Jane Cameron National Archives, as well as engaging in friendly conversation there. The Falkland Islands Community School library was another excellent source for books and periodicals. My research also benefited from in-person and electronic correspondence with an energetic and mutually supportive group of scholars who had also carried out fieldwork in the islands, particularly geographers Matt Benwell, Wayne Bernhardson, Klaus Dodds, and Alasdair Pinkerton.

In Argentina, I am especially grateful for the generous support of Rosana Guber at the Instituto de Desarrollo Económico y Social in Buenos Aires. She welcomed me into her home and permitted me to raid her “bunker,” a treasure of rare and highly informative sources on Malvinas. It was a blessing to have such a gracious interlocutor with overlapping training in anthropology. In Río Gallegos, I had the unusual opportunity to attend the first-ever reunion of defected islanders in Argentine Patagonia. This state-sponsored attempt to reconnect broken networks of lost kin revealed surprising expressions of loyalty among Patagonian settlers and their estranged islander relatives, highlighting the importance of kinship for understanding divergent geopolitical perspectives. My ethnographic observations from that reunion were omitted from this book manuscript, but three key figures involved have since passed away, and I am grateful for the opportunity to have met them: Alejandro (Alec) Betts, Uriel Erlich, and Marcelo Vernet. Vernet—a poet, writer, and independent historian—was especially generous with his time and encyclopedic knowledge. I can still picture him grinning widely as he introduced me to others: “Este es un antropólogo y no un antropófago” (“This is an anthropologist, not a cannibal”). As with the islanders, there may be other Argentine interlocutors who figured in this research, but for reasons of confidentiality, I have omitted their names. They, too, will recognize themselves in the text, and my sincerest thanks go to them. Finally, I want to extend thanks to the Archivo General de la Nación and the Universidad de la Patagonia Austral for research support.

In the United Kingdom, the geography department in the School of Environment, Education and Development (SEED) and the Society and Environment Research Group at the University of Manchester supported the early stages of

writing. I am particularly grateful to Erik Swyngedouw for his generous sponsorship, expert encouragement, and dynamic critical thinking as outside reader and mentor.
