Many of the influences that have shaped this book defy acknowledgment through proper names. How to acknowledge the otherworldly light of the midnight sun on a long day in Reykjavík that crystallized some of the initial ideas for this book? How to credit the structural liberties and pressures of the American research university, and the chain of contingencies that has led me to find myself in one of them? How to account for the diffuse influence of a Romantic concept of literature developed around 1800 in Northern Germany on the Southern Austrian provincial milieu where I grew up?
