HENRY E. ALLISON is Professor of Philosophy at the University of California, San Diego. He has written on a variety of topics in the history of modern philosophy and the philosophy of religion. He is the author of *Lessing and the Enlightenment* (1966), *Benedict de Spinoza* (2d ed. 1987), and *Kant's Transcendental Idealism* (1983). He has also edited and translated *The Kant–Eberhard Controversy* (1973).

LEWIS WHITE BECK is Burbank Professor of Intellectual and Moral Philosophy Emeritus, University of Rochester. He has edited and translated many of Kant's writings and has written extensively in the history of modern philosophy. Among his many publications are *A Commentary on Kant's Critique of Practical Reason* (1960), *Early German Philosophy* (1969), and *The Actor and the Spectator* (1975).

REINHARD BRANDT is Professor of Philosophy at the University of Marburg and Director of the Kant Archiv, Marburg. He has edited, among other things, a volume on *Rechtstheorien der Aufklärung* (1981) and is coeditor of *Kant-Forschungen*. His books include *Eigentumstheorien von Grotius bis Kant* (1974) and *Die Interpretation philosophischer Werke* (1984).

WOLFGANG CARL is Professor of Philosophy at the University of Göttingen. He is the author of *Existenz und Predikation* (1976) and

ECKART FÖRSTER is Assistant Professor of Philosophy at Stanford University. He is the editor and translator (with Michael Rosen) of Kant's *Opus postumum*, to be published next year.

PAUL GUYER is Professor of Philosophy at the University of Pennsylvania, Philadelphia, and chairman of his department. In addition to many journal articles he has authored two books, *Kant and the Claims of Taste* (1979) and *Kant and the Claims of Knowledge* (1987). He has also coedited a volume of *Essays in Kant's Aesthetics* (1982).

SIR STUART HAMPSHIRE is Bonsall Professor of Philosophy at Stanford University and formerly Warden of Wadham College, Oxford. He has published widely in philosophy and related areas, especially on literature. His many books include *Spinoza* (2d ed. 1987), *Thought and Action* (2d ed. 1982), *Public and Private Morality* (1978), and *Morality and Conflict* (1983).

DIETER HENRICH is Professor of Philosophy at the University of Munich. He has published studies in a number of philosophical areas, most notably on Kant, Fichte, Hegel, and Hölderlin. Among his many books are *Der ontologische Gottesbeweis* (1960), *Hegel im Kontext* (1967), *Identität und Objektivität* (1976), *Fluchtlinien* (1982), and *Der Gang des Andenkens* (1987).

BARBARA HERMAN is Associate Professor of Philosophy at the University of Southern California, Los Angeles. She has published many articles in moral and political philosophy and is currently working on a book on Kant's moral philosophy.

ROLF-PETER HORSTMANN is Professor of Philosophy at the University of Munich. The author of many articles on topics in Kant and German Idealism, he has also edited several books, among them two volumes of the *Historisch-kritische Hegel Ausgabe*. His book *Ontologie und Relationen* appeared in 1984.

JOHN RAWLS is James Bryant Conant University Professor, Harvard University. He has published many influential articles in moral and political theory. His book *A Theory of Justice* (1971) has been translated into eight languages.
