**Katie Barclay** is an ARC Discovery Early Career Research Fellow in the ARC Centre for the History of Emotions and School of History & Politics, University of Adelaide, Australia. She is the author of *Love, Intimacy and Power: marriage and patriarchy in Scotland, 1650–1850* (2011) which won the Women's History Network Book Prize and the Hume Brown Prize in Scottish History, and of numerous articles on emotion and family life in Scotland and Ireland. She has recently edited, with Deborah Simonton, *Women in Eighteenth-Century Scotland: Intimate, Intellectual and Public Lives* (2013).

Jamie Reid Baxter is Honorary Research Fellow in Scottish History at Glasgow University. He has published widely on sixteenth- and early-seventeenth-century Scottish history, music, literature, and religious life, including *Elizabeth Melville*, *Lady Culross: Poems from Manuscript, with Ane Godlie Dreame* (2010) and *Jhone Angus, Monk of Dunfermline, and Scottish Reformation Music* (2011). **Stuart Campbell** is Head of the Treasure Trove Unit, National Museums of Scotland, responsible for assessing newly discovered archaeological objects in Scotland.
