James Bothwell is Lecturer in Later Medieval History in the University of Leicester. He is the author of *Edward III and the English Peerage: Royal Patronage, Social Mobility and Political Control in Fourteenth-Century England* (2004) and *Falling from Grace: Reversal of Fortune and the English Nobility 1075–1455* (2008, 2010), and editor of various volumes on fourteenth-century history. His research interests span from the royalty and nobility to the peasantry, and he is at present researching topics as diverse as medieval charity, the 1381 revolt and Edward III's attitude towards death.

S. W. Dempsey is a doctoral student at the Australian National University. His current work focuses on 'historical' argument in medieval and early modern English political thought. He was a Visiting Scholar at the University of St Andrews in 2017. His research concentrates on the history of political thought, with a specialization in Greece, Rome and early European ideas from the twelfth to the sixteenth centuries.
