None of this book would have been possible without a great deal of openness and support on the part of others. Most significant was the generous funding from the British Academy that provided me with research leave for 2001–2003. The tardiness of completing this project is in part related to other research opportunities that presented themselves in that period, and which without doubt enriched the initial intentions of the project. My involvement, thanks to the intervention of Jo Labanyi, with Luisa Passerini's *Europe in Love* project at the KWI in Essen took place during this research period, and enabled much fruitful contact with other scholars from Europe working on the early twentieth century. Two publications emerged from that project that reappear in revised form in this work, the chapter on Russia, and the part of Chapter 4 that deals with the *Revista de Occidente*. I also continued to collaborate with Richard Cleminson on eugenics and sexual reform in early twentieth-century Spain. This area of interest had been sparked by contact with Tom Glick, who had generously shared with me a wealth of information about Hildegart Rodríguez. I had intended to have a chapter in this study on the trafficking of knowledge about sexuality and draw on it partially for Chapter 9. This work, however, came out in much-expanded form in a book on Hildegart, *Sex and Society in Early Twentieth-Century Spain* (University of Wales Press 2007). I was also able to explore various themes of this study in symposia kindly supported in Cambridge by CRASSH (Centre for Research in Arts, Social Sciences and Humanities): conferences on the World League for Sexual Reform (2000), on Alternative Discourses in Early Twentieth-Century Spain: Intellectuals, Dissent and Subcultures of Mind and Body (2002), an international workshop on Heredity, Degeneration and Eugenics (2006), and an international conference on Eugenics, Sex and the State (2007). I am grateful also to other venues where I was able to present sections of this year: conferences in Stirling, Swansea and Cambridge, and seminars in Nottingham, Aberdeen, Sheffield, London and Essen.
