Tal Elmaliach is a Post-Doc fellow in the Center for Israel Studies, The Ben-Gurion Research Institute for the Study of Israel and Zionism, Ben-Gurion University of the Negev. He wrote his PhD dissertation at the University of Haifa on the subject of Hakibbutz Haartzi-HaShomer haTza'ir and Mapam between the Years 1956–1977. This work has been recently published in a book in Hebrew (under The Ben-Gurion Research Institute press and the Open University Press) and will soon be published in English (under Syracuse University Press). He is currently working on a new research project dealing with Radical socialist-Zionism in the United States in the 1930s and the 1960s.

Frank Jacob is Professor for Global History (nineteenth and twentieth centuries) at Nord Universitet, Norway. Before this he held positions at Würzburg University, Germany and the City University of New York, USA.
