He is the cofounder and former director of the Venice international literary festival Incroci di civiltà.

Bolette B. Blaagaard is Associate Professor of Media and Communications at Aalborg University, Copenhagen, Denmark. Her work deals with multiple intersections of journalism, digital media, citizenship, and postcolonial theory. She is the co-editor of among others *Citizen Media and Public Spaces* (2016), *The Routledge Encyclopedia of Citizen Media* (2020), and *Postcolonial Publics: Art and Citizen Media in Europe* (2023), and the author of *Citizen Journalism as Conceptual Practice. Postcolonial Archives and Embodied Political Acts of New Media* (2018).

Elena Brugioni is Associate Professor (*Livre Docente*) in Comparative Literature at the Department of Literary Theory of the University of Campinas UNICAMP. She is co-coordinator of KALIBAN, a research center in Postcolonial Studies and World-Literature (IEL/CNPq). She develops research in the fields of comparative African literature, Indian Ocean studies, and postcolonial theory and published widely on Mozambican literature, contemporary African novels, Indian Ocean literatures, and postcolonial theory. She is the author of the book *Literaturas Africanas Comparadas. Gianmaria Colpani is Assistant Professor of Gender and Postcolonial Studies in the Department of Media and Culture Studies, at Utrecht University. He has published on the work of Stuart Hall, postcolonial theory, queer Marxism and queer of color critique, and sexual politics in Europe. He is the co-editor of *Postcolonial Transitions in Europe: Contexts, Practices and Politics* (Rowman & Littlefield, 2016) and the special issue "Postcolonial Responses to Decolonial Interventions" (*Postcolonial Studies*, 2022).

Adriano José Habed is Assistant Professor of Gender and Postcolonial Studies the Department of Media and Culture Studies, at Utrecht University. He has published on critique and postcritique,

She is the editor of the African Literary Series for the Milan-based publisher Francesco Brioschi Editore.

Peter I. Maurits is postdoctoral fellow at the University of Erlangen-Nürnberg. His research focuses on African literature and genre, and he is particularly interested in the way in which form changes when it moves through time and space. His first book is titled *The Mozambican Modern Ghost Story* (2022) and he is currently writing a book about African science and speculative fiction.

Paulo de Medeiros is Professor of Modern and Contemporary World Literatures and Head of the Department of English and Comparative Literary Studies at the University of Warwick. He works on questions of Critical Theory, Cultural Memory, and Postcolonial Studies. Ana Cristina Mendes is a Professor of English Studies at the School of Arts and Humanities, University of Lisbon, Portugal, and Chair of the ACS – Association for Cultural Studies (2022–26). She uses cultural and postcolonial theory to examine literary and screen texts (in particular, intermedia adaptations) as venues for resistant knowledge formations to expand upon theories of epistemic injustice. Besides an interest in the politics and aesthetics of contemporary screen media, she has published on Indian writing in English, Shakespearean adaptation in India, and Victorian cultural afterlives, with a focus on the British empire.

Sandra Ponzanesi is a Professor of Media, Gender and Postcolonial Studies at the Department of Media and Culture Studies/Graduate Gender Programme at Utrecht University, the Netherlands. Max Silverman is Professor of Modern French Studies at the University of Leeds.
