- Fig. 7:** The first set of manikins from the Self-Assessment Manikin, a widely used tool for assessing experimental subjects’ subjective valence (or their perception of a stimulus’ valence). Subjects select the manikin that best represents how they feel (or how they feel toward a stimulus), with options ranging from pleasure (left) to displeasure (right). Additional series of stylized figures representing arousal (from calm to tense) and dominance (from submissive to dominant) are also part of the test but are omitted here.
