Damjan Božinović is a PhD candidate in South Slavic studies at the University of Oslo, Norway. His research fields are transnational literature, memory studies, and migration studies. His current project focuses on multilingualism in post-Yugoslav fiction. Mónika Dánéi is Assistant Professor of Comparative Literature and Cultural Studies at Eötvös Loránd University, Budapest. She was a postdoctoral researcher at the University of Oslo (2018 – 2021). Her research fields are world literature, Eastern European Studies, multilingualism, space and body theory, memory and gender studies connected to post-socialist societies. She is co-editor of the volumes *Event – Trauma – Publicity* (2012) and *Space – Theory – Culture. An Interdisciplinary Handbook of the Space* (2019), and the author of *Transparent Frames: The Intimacy of Reading* (2013) and *Language-Carnival: The Poetics of Hungarian Neo-Avant-Garde Artworks* (2016).

Colin Davis is Emeritus Professor of French and Comparative Literature at Royal Holloway, University of London, UK. His research fields include philosophical approaches to literature and film, hermeneutics, trauma studies, and Holocaust literature. His most recent books are *Traces of War: Interpreting Ethics and Trauma in Twentieth-Century French Writing* (2018), *The Routledge Companion to Literature and Trauma*, co-edited with Hanna Meretoja (2020), *Silent Renoir: Philosophy and the Interpretation of Early Film* (2021), and *Literature, Interpretation and Ethics* (2024).

John Greaney is a Marie Skłodowska-Curie Fellow at Goethe University Frankfurt. He was previously a Fulbright Postdoctoral Fellow at the University of Pennsylvania, and an Irish Research Council Scholar at University College Dublin. He is the author of *The Distance of Irish Modernism: Memory, Narrative, Representation* (2022) and co-editor of *Irish Modernisms: Gaps, Conjectures, Possibilities* (2021). His work has been published in *Textual Practice*, *Journal of Modern Literature*, *Irish Studies Review* and *Derrida Today*, amongst other venues.

Aigi Heero is Associate Professor of German Language and Didactics at Tallinn University, Estonia. Her current research focuses on contemporary German literature, memory studies, the intersection of literature and memory, and digitalisation in German didactics. She has published on the literature of the transition era in Estonia, including “Die Wendezeit in Estland: Gohar Markosjan-Käspers Roman *Elena*” (2024). Her recent editorial work includes the volume *Baltische Erzähl- und Lebenswelten* (2024).

Kaisa Kaakinen works as Research Coordinator at the Helsinki Collegium for Advanced Studies. She earned a PhD in comparative literature from Cornell University. Her current research focuses on historical and sociological imagination in literature, and her publications deal with historical narration, memory and trauma studies, and transnational literary studies. Her monograph *Comparative Literature and the Historical Imaginary. Reading Conrad, Weiss, Sebald* (2017) studies comparative reading in the context of three twentieth-century authors and the contemporary discipline of comparative literature.

Eneken Laanes is Professor of Comparative Literature at Tallinn University, Estonia and the Project Leader of “Memory and Environment: The Intersection of Fast and Slow Violence in Transnational European Literatures” (2025 – 2029). Her research fields are comparative literature, transnational literature, multilingualism, memory studies, and Eastern European memory cultures. Her recent publications include *Cultural Memorial Forms*, a special issue of *Memory Studies* (2021) co-edited with Hanna Meretoja; *Perpetrators, Collaborators and Implicated Subject in Central and Eastern Europe*, a special issue of SEEJ (2023) co-edited with Margaret Comer; and “Katja Petrowskaja’s Translational Poetics on Memory” (New German Critique 2024).

Unni Langås is Professor of Scandinavian Literature at the University of Agder, Norway. She has published several books and anthologies on body representations, gender, poetry, and interart studies, including *Terrorizing Images. Trauma and Ekphrasis in Contemporary Literature*, co-edited with Charles I. Armstrong (2020). She is head of the research project “Making Memories. Contemporary Aesthetic Articulations of Norway in the Second World War”.

Hanna Meretoja is Professor of Comparative Literature and Director of SELMA: Centre for the Study of Storytelling, Experientiality and Memory at the University of Turku, Finland. Her main research fields are narrative studies, cultural memory studies, and literature, and philosophy. Her publications include *The Ethics of Storytelling: Narrative Hermeneutics, History, and the Possible* (2018), *The Narrative Turn in Fiction and Theory* (2014), and the co-edited volumes *The Use and Abuse of Stories* (2023), *The Routledge Companion to Literature and Trauma* (2020, with Colin Davis), and *Storytelling and Ethics* (2018, with Colin Davis).

Jessica Ortner is Associate Professor at the University of Southern Denmark. Her research areas include memory studies, transcultural memory, European identity and Jewish literature. Between 2019 and 2023, she was the primary investigator of the collaborative project on post-Yugoslav migrant literature and the circulation of Bosnian wartime memory to Denmark, Germany, and the UK. She has published the monographs *Poetologie “nach Auschwitz”: Narratologie, Semantik und sekundäre Zeugenschaft in Elfriede Jelineks Roman Die Kinder der Toten* (2016), and *Transcultural Memory and European Identity in Contemporary German-Jewish Migrant Literature* (2022).

Rafael Pérez Baquero is an Assistant Professor of Philosophy at the University of Murcia. His research areas are memory studies, philosophy of history, and the contemporary history of Spanish philosophy. His publications include *Trauma, recuerdo y duelo. Una aproximación filosófica a las relaciones entre memoria e historia* (2021), *Exilio y Melancolía. Utopías frustradas en el pensamiento filosófico del destierro republicano español* (2024), and his editorial work on the volume *Terrifying Europe: History and Memory of Terrorism in European Identity* (2024).

Anita Pluwak is Associate Teaching Professor of Eastern European and Polish Studies at the University of Copenhagen, Denmark. In 2021 – 2024 she was a postdoctoral researcher on the European Research Council funded project “Translating Memories: Eastern European Past in the Global Arena” at Tallinn University, Estonia. Her research fields include cultural studies, comparative literature, and popular genres. Her most recent work deals with conspiracy fiction and conservative-themed novels from contemporary Poland.

Tea Sindbæk Andersen teaches East European Studies at the University of Copenhagen. Tea’s research focuses on cultural memory, identity politics, and popular culture in the Yugoslav area. She is

the author of *Usable History? Representations of Yugoslavia's Difficult Past from 1945 to 2002* (2012), *Disputed Memory. Emotions and memory politics in Central, Eastern and South-eastern Europe* (2016) co-edited with Barbara Törnquist-Plewa, *The Twentieth Century in European Memory* (Brill 2018), and the special issue of *Memory Studies* on “Memories of Joy” (2019) co-edited with Jessica Ortner.

Una Tanović is a Visiting Assistant Professor at the University of Massachusetts, Amherst. Her research bridges the fields of translation studies, migration studies, and memory studies. Her recent publications include a chapter on post-Yugoslav translingual literature in the *Routledge Handbook of Literary Translingualism*. Her current book project explores the role of epistolarity in contemporary refugee literature. She has translated works by the Bosnian writers Semezdin Mehmedinović, Miljenko Jergović, and Adisa Bašić, with her translations appearing in *The Massachusetts Review* and *Freeman's*.

Hanna Teichler is a postdoctoral Research Associate at the Department of English and American Studies at Goethe University, Frankfurt. She specialises in Anglophone literatures, memory studies, oceanic literature and cultures, environmental humanities, and postcolonial literatures. Hanna is the co-editor of the book series *Mobilizing Memories* and of the *Handbook Series in Memory Studies* (with Rebekah Vince). She co-directs the *Frankfurt Memory Studies Platform* with Astrid Erli. She is also co-editor-in-chief of the journal *Memory Studies Review*.

Anja Tippner is Professor of Slavic Literatures at the University of Hamburg. Her research fields include concepts of documentation, auto/biography and life-writing; representations and translation of the Holocaust and (post-)catastrophes; and Jewish literatures in Eastern Europe. Her most recent books are *Narratives of Annihilation, Confinement and Survival: Camp Literature in a Transnational Perspective* (co-edited with Anna Artwińska, 2019); *The Afterlife of the Shoah in Central Eastern European Cultures: Concepts, Problems, and the Aesthetics of Postcatastrophic Narration* (co-edited with Anna Artwińska, 2022); and *The Art of Witnessing. Documentary Literature, Film and Theatre in the Baltics, Belarus, Russia, and Ukraine* (co-edited with Johanna Lindbladh, forthcoming).

Stijn Vervaet is an Associate Professor in Bosnian/Croatian/Serbian and Balkan Studies at the University of Oslo, Norway. His research interests lie in Yugoslav literature, comparative literature, cultural history of the Balkans and Central Europe, memory studies, and multilingualism. He is the author of a book on the construction of national identities in Bosnia and Herzegovina under Austro-Hungarian rule (2013), and of *Holocaust, War and Transnational Memory: Testimony from Yugoslav and Post-Yugoslav Literature* (2018).
