Doudou Diène was born in Senegal. He holds a Law degree from the University of Caen, a Ph.D. in Public Law from the University of Paris, and a diploma in Political Science from the Institut d'Études Politiques in Paris. Mr Diène joined the UNESCO Secretariat in 1977 and in 1980, he was appointed Director of the Liaison Office with the United Nations Permanent Missions and departments in New York. In 1993, he was appointed Director of UNESCO Division of Intercultural Projects, including the Slave Route (now renamed as Routes of Enslaved Peoples), Routes of Faith, Routes of al-Andalus, and Iron Roads in Africa. In 2002, Mr Diène was appointed by the Commission on Human Rights as Special Rapporteur on Contemporary Forms of Racism, Racial Discrimination, Xenophobia and Related Intolerance. In 2017, he was appointed by François Hollande, former President of France, to lead the public interest group "Mission on the Memory of Slavery, Treaties and their Abolition." He is the author of numerous publications and has chaired and been the distinguished guest on various panels, as well as radio and television programmes.

Scherto R. Gill is Professor of Research and Director of the Global Humanity for Peace Institute at the University of Wales Trinity Saint David. She is also a Senior Fellow at the Guerrand-Hermès Foundation for Peace and a Research Fellow at the University of Sussex. Scherto serves on the Editorial Board of the *Journal of Studies in Spirituality*. She is a Life Fellow of the Royal Society of Arts (FRSA) and a laureate of the 2022 Luxembourg Peace Prize. Additionally, she is a Trustee of the Rising Peace Forum and a Board Member of the Spirit of Humanity Forum.

Garrett Thomson is the Chief Executive Officer of the Guerrand-Hermès Foundation for Peace and holds the Compton Chair in Philosophy at the College of Wooster. He is the author, co-author, or coeditor of 27 books. His works on peace and well-being include *Happiness*, *Flourishing and the Good Life* (2020), *Understanding Peace Holistically* (2019), *On the Meaning of Life* (2002), and *Needs* (1987).
