Ángel Alcalde is Senior Lecturer in History at the University of Melbourne. As a modern historian, he specializes in the transnational history of fascism, the Spanish Civil War and the Francoist regime. His latest monograph *War Veterans and Fascism in Interwar Europe* (Cambridge 2017).

Christian Hjorth Bagger is a Doctoral Candidate in the School of Historical and Philosophical Studies at the University of Melbourne. His research focuses on civil war, the socio-political elite, and the *matronae* of late Republican Rome.

Federica Carugati is Senior Lecturer in History and Political Economy at King's College London. She holds a BA and MA in Philosophy from the University of Bologna, and a joint PhD/MA in Classics and Political Science from Stanford University. Federica is the author of several articles and two books: *A Moral Political Economy: Present, Past and Future* (Cambridge 2021) and *Creating a Constitution: Law, Democracy and Growth in Ancient Athens* (Princeton 2019).

Annelien de Dijn is Professor of Modern Political History and chair of the Political History Department at Utrecht University and specializes in the history of political thought. Her most recent books include *Freedom: An Unruly History* (Harvard 2020) and *Rethinking Liberty Before Liberalism* (Cambridge 2022).

J. Lea Beness is an Honorary Associate Professor in the Department of History and Archaeology, Macquarie University. Amongst her research interests are the politics of the Late Roman Republic, women and gender in the Graeco-Roman world and landscape archaeology. She is a co-director (with Tom Hillard) of the Torone Harbour Project.

Christopher J. Dart is an Australian Research Council funded Postdoctoral Research Associate at the University of Melbourne. His research focuses on the sociopolitical history of the Roman Republic and the early Empire and is the author of *The Social War, 91 to 88 BCE: A History of the Italian Insurgency against the Roman Republic* (Routledge 2014).

Tim Elliott is a PhD researcher at the University of Birmingham, UK, investigating populist politics in the late Roman republic and the modern day. His research interests are in political theory, Roman history, classical reception, and the history of ideas.

Nicholas George is a PhD Candidate studying Classics and Ancient History at the University of Adelaide. His research focuses on administration, particularly provincial administration, in the Middle and Late Roman Republic. He has previously worked on the intersection between space and violence in the Roman imagination.

Lisa Hill is Professor of Politics at the University of Adelaide. She works on the intellectual history of the Western political and economic tradition, democratic theory and electoral studies. She is a Fellow of the Academy of the Social Sciences of Australia, Program Director at the Stretton Institute for Public Policy, and Research Chair of the Centre for Public Integrity, an anti-corruption watch-dog.

Tom Hillard is an Honorary Associate Professor in the Department of History and Archaeology, Macquarie University. Amongst his research interests are the politics of the Late Roman Republic, Roman social history and the archaeology of ancient harbours. He is, with Lea Beness, a chief investigator for the Macquarie Roman Biographical Dictionary Project.

Catherine Kovesi is a Professor of History at the University of Melbourne. She researches the discourses regarding luxury consumption in late medieval Italy, and Venetian and Florentine social and cultural history. She has a deep knowledge of the city of Venice, bringing students there over many years, and curating bespoke cultural visits to the city.

Thibaud Lanfranchi is maître de conférences at the University Jean Jaurès in Toulouse and member of the Institut Universitaire de France. He specialises in the early and middle Roman Republic, particularly in institutional and socio-political questions, as well as the reception of Antiquity. In addition to his monograph on the tribunes of the *plebs* at the beginning of the Republic (Rome 2015), he has published numerous articles as well as edited the volumes *Autour de la notion de sacer* (Rome 2018) and (in collaboration with Corinne Bonnet) *Les mots de l'Antiquité après l'Antiquité* (Toulouse 2023).

Peter McPhee was appointed to a Personal Chair in History at the University of Melbourne in 1993. He was the University's first Provost in 2007–2009. He is now an Emeritus Professor. His most recent books are *Liberty or Death: the French Revolution* (New Haven, CT 2016) and *An Environmental History of France: Making the Landscape 1770–2020* (London 2024).

Kit Morrell is the Susan Blake Lecturer in Classics and Ancient History at the University of Queensland. Her research centres on the political and legal history of the late Roman republic, including the idea of the rule of law and the practice and discourse of reform in republican Rome.

Francisco Pina Polo is Professor of Ancient History at the Universidad de Zaragoza (Spain). He is author of books on the Roman Republic concerning popular assemblies (*contiones*), the quaestorship, the consulship and the consulars, as well as of a biography of Cicero. He is co-director of the series of monographs on the Roman Republic *Libera Res Publica*.

David Rafferty is a Roman historian at the University of Adelaide whose work focuses on the political history of the Late Republic. His first monograph, *Provincial Allocations in Rome, 123–52 BCE* appeared in 2019.

Ronald T. Ridley was Inaugural Teaching Fellow in Ancient History at the University of Sydney (1962–1964), then taught Ancient World History at the University of Melbourne for forty-one years, retiring from a personal chair. He is FSA, FRHistS, Soc.Corr.Pont.Accad.Arch.Rom., and FAHA, and was awarded the Princess Daria Borghese gold medal (2019) and honorary Italian citizenship (2022) for contributions to the history of Rome.

Cristina Rosillo-López is Professor of Ancient History at the University Pablo de Olavide, Seville. She is the author of *Public Opinion in the Late Roman Republic* (2017) and *Political Conversations in the Late Roman Republic* (2022), and co-editor of, among others, *Cives Romanae. Roman Women as Citizens during the Republic* (2024). She has written on Republican political history, gender and social history.

Tonya Rushmer completed her Doctorate at the University of Sydney in 2024. Her dissertation examined the politics and practicalities of the Roman Republican grain supply, from its foundation until Caesar.

Amy Russell is Associate Professor of Classics and History and Director of the Program in Early Cultures at Brown University. She is the author of *The Politics of Public Space in Republican Rome* (Cambridge 2016), and works on definitions of the *populus* and other topics in republican political culture.

Matt Simonton is Associate Professor of History at Arizona State University. His work to date has focused on constitutional struggles between democracy and oligarchy in ancient Greece, demagoguery, social conflict, the spread of democracy in the Greek world, and the history of political thought.

James Tan is Senior Lecturer in Classics and Ancient History at the University of Sydney. He is the author numerous papers on Roman Republican History, as well as *Power and Public Finance, 264–49 BCE*, (Oxford 2017).

Jeff Tatum is Professor of Classics at Victoria University of Wellington and is a Fellow of the Royal Society of New Zealand. His most recent books are *A Noble Ruin: Mark Antony, Civil War, and the Collapse of the Roman Republic* (Oxford 2024) and, with Laurel Fulkerson, *A History of Latin Literature from its Beginnings to the Age of Augustus* (Cambridge 2024).

Frederik Juliaan Vervaeke is Professor of Ancient History at the University of Melbourne. He has published widely in Roman socio-institutional and political history, and Roman public law, including a recent monograph on *Reform, Revolution, Reaction – A Short History of Rome from the Origins of the Social War to the Dictatorship of Sulla* (Sevilla and Zaragoza 2023) and substantial chapters in the *Oxford Handbook of Roman Law and Society* (2016) and the Second Edition of the *Oxford History of the Roman World* (forthcoming).
