Gillian Beer is King Edward VII Professor of English Literature at University of Cambridge, Dame Commander of the Order of the British Empire, and past President of Clare Hall, University of Cambridge. Her publications include Alice in Space: The Sideways Victorian World of Lewis Carroll (2016), Darwin's Plots (1983; 3rd ed. 2009), Open Fields (1997), Virginia Woolf: The Common Ground (1996), Forging the Missing Link (1992), Arguing with the Past (1989), George Eliot (1986), and Meredith: A Change of Masks (1970). Beer also holds an Honorary Doctor of Letters from Oxford University and from Harvard University, and has served on and chaired the Adjudication Panel for the Man Booker Prize.

Alan Bewell is Professor at the University of Toronto. He is author of Natures in Translation: Romanticism and Colonial Natural History (2017), Romanticism and Colonial Disease (1999), and Wordsworth and the Enlightenment (1989); coauthor of Educating the Imagination: Northrop Frye, Past, Present, Future; and editor of Medicine and the West Indian Slave Trade (1999). He is currently at work on another book, Romanticism and Mobility. He is the recipient of a Guggenheim Fellowship and several SSHRC grants as well as the Northrop Frye Award at the University of Toronto for excellence in teaching and research, and is a Fellow of the Royal Society of Canada. He serves on the editorial boards of Studies in Romanticism, Nineteenth-Century Literature, and the Palgrave series The Enlightenment, Romanticism, and the Cultures of Print.

Joel Faflak is Professor of English and Theory at Western University, where he is Director of the School for Advanced Studies in the Arts and the Humanities. He is author of *Romantic Psychoanalysis* (2008), coauthor of *Revelation and Knowledge* (2011), editor of De Quincey's *Confessions of an English Opium-Eater* (2009), and editor or coeditor of eight volumes, including *The Romanticism Handbook* (2011),

The Handbook to Romanticism Studies (2012), The Public Intellectual and the Culture of Hope (2013), and Romanticism and the Emotions (2014). He has been the recipient of several SSHRC grants, and won the 2002 Polanyi Prize for Literature.

Noah Heringman is Associate Professor of English at the University of Missouri, where he teaches on poetry, aesthetic theory, and the cultural history of science. He has published Sciences of Antiquity: Romantic Antiquarianism, Natural History, and Knowledge Work (2013), Romantic Rocks, Aesthetic Geology (2004), and the edited collection Romantic Science: The Literary Forms of Natural History (2003), as well as co-editing "Romantic Antiquarianism" (with Crystal B. Lake) for Romantic Circles Praxis. His articles have appeared in Studies in English Literature 1500–1900, Studies in Romanticism, Earth Sciences History, and The Huntington Library Quarterly, and in A Concise Companion to the Romantic Age, A Companion to Werner Herzog, and The Routledge Companion to Literature and Science.

Theresa M. Kelley is Marjorie and Lorin Tiefenthaler Professor of English at the University of Wisconsin – Madison. She has received awards and fellowships from the National Endowment for the Humanities, the Simon D. Guggenheim Foundation, Henry E. Huntington Library, and the Institute for Research in the Humanities at the University of Wisconsin-Madison. She is author of *Clandestine Marriage: Botany and Romantic Culture* (2012), *Reinventing Allegory* (1998), and *Wordsworth's Revisionary Aesthetics* (1988); the editor of the issue "Romantic Frictions" for the *Romantic Circles Praxis* series; and co-editor of *Romantic Women Writers: Voices and Countervoices* (1995) and *The Matter of the Archive* (forthcoming). She is at present writing *Reading for the Future* and *Color Matters*.

Maureen N. McLane, Professor of English at New York University, is the author of Balladeering, Minstrelsy, and the Making of British Romantic Poetry (2008), Romanticism and the Human Sciences (2000), and co-editor of The Cambridge Companion to British Romantic Poetry (2008). She has written extensively on romantic mediality, comparative poetics, the human sciences, and contemporary poetries in English. She has also published five books of poetry, most recently Mz N: the serial: a poem-in-episodes (2016) and Some Say (2017). Her book My Poets (2012), an experimental hybrid of memoir and criticism, was a Finalist for the National Book Critics Circle Award in Autobiography. Ongoing projects include work on rhyme, "compositionist" poetics, "choratopes," and lyric discontents. She continues to work on (and with) poets dead and alive.

Andrew Piper is Associate Professor in the Department of Languages, Literatures, and Cultures and an associate member of the Department of Art History

and Communication Studies at McGill University. He is also co-founder of FQRSC-funded research group Interacting with Print: Cultural Practices of Intermediality, 1700–1900. Piper has published Book Was There: Reading in Electronic Times (2012) and Dreaming in Books (2009). His articles have appeared in European Romantic Review, RaVoN, Goethe Yearbook, The New Everyday, and PMLA, and in collections such as Women in German Yearbook, Bookish Histories, Spatial Turns, and Book Illustration in the Long Eighteenth Century.

Tilottama Rajan is Distinguished University Professor, Canada Research Chair (Tier 1), and Director of the Centre for the Study of Theory and Criticism at Western University. She is a Fellow of the Royal Society of Canada, and held the H.I. Romnes Professorship at the University of Wisconsin, Madison. She has published Romantic Narrative (2011), Deconstruction and the Remainders of Phenomenology (2002), The Supplement of Reading (1990), and Dark Interpreter (1980); edited Mary Shelley's Valperga (1998); and co-edited Idealism without Absolutes (2004), After Poststructuralism (2002), Romanticism and the Possibilities of Genre (1998), and Intersections: Nineteenth-Century Philosophy and Contemporary Theory (1995).

Robert J. Richards is Morris Fishbein Professor of the History of Science and Medicine, University of Chicago, where he is also Professor in the Departments of Philosophy, History, and Psychology, Director of the Fishbein Center for the History of Science and Medicine, and Professor on the Committee on Conceptual and Historical Studies of Science. He is author of *The Tragic Sense of Life* (2009), *The Romantic Conception of Life* (2002), *The Meaning of Evolution* (1992), and *Darwin and the Emergence of Evolutionary Theories of Mind and Behaviour* (1987), and is co-editor of *The Cambridge Companion to* The Origin of the Species (2009) and *Darwinian Heresies* (2004). He has also been Mellon Professor at Grinnell College (2007).

Matthew Rowlinson is Professor of English at Western University. He is the author of *Real Money and Romanticism* (2010) and *Tennyson's Fixations* (1994), and editor of Tennyson's *In Memoriam* (2014). He has published essays in *The Oxford Encyclopedia of British Literature, The Blackwell Companion to Victorian Poetry, Boundary 2, differences, PMLA, Romantic Circles, Victorian Poetry, Victorian Studies, and Yale Journal of Criticism.*

Joan Steigerwald is Associate Professor in the Department of Humanities, and the Graduate Programs in Humanities, Science and Technology Studies, and Social and Political Thought, at York University. She has just completed a book entitled

Experimenting at the Boundaries of Life: Organic Vitality in Germany around 1800. She has edited two special issues for Studies in the History and Philosophy of the Biological and Biomedical Sciences, "Entanglements of Instruments and Media in Exploring Organic Worlds" in 2016, and "Kantian Teleology and the Biological Sciences" in 2006. She has published numerous articles on Goethe, Humboldt, Kant, Schelling and the German life sciences. Her new project is Object Lessons of a Romantic Natural History.

Gábor Áron Zemplén is Associate Professor at ELTE Business School (Budapest) and Senior Researcher at the MTA BTK Lendület Morals and Science Research Group. He lectured at the Budapest University of Technology and Economics, Hungary (BME, 2002–2017, Philosophy and the History of Science), received postdoctoral fellowships from the Max Planck Institute for the History of Science in Berlin and the Collegium Budapest, and held teaching positions in England, Bavaria (where he was also researcher at the Deutsches Museum, Munich), and Switzerland (writing a textbook on theories of light, colour, and vision, University of Bern).
