CONTRIBUTORS

CHARLES J. ADAMS is Professor of Islamic Studies and former Director, Institute of Islamic Studies, McGill University. He has published widely on topics both within the general theory of the History of Religions and Islam. His major research interest is Islamic India, and he has been engaged for some time in the preparation of a book on Abū'l-A'lā Mawdūdī.

MAHMOUD AYOUB was educated at the American University of Beirut, University of Pennyslvania, and Harvard University, from where he received his Ph.D. in the History of Religion in 1975. He is presently Research Associate at the Centre for Religious Studies, University of Toronto. Among his publications are Redemptive Suffering in Islam (1978) and The Qur'ān and its Interpreters (1984)—the first volume of a projected 10-volume series—as well as many articles on Islam and Christology. Research in progress includes Ja'far al-Ṣādiq, Life and Times and Towards an Islamic Christology: Studies in Muslim Views of Jesus, the latter being sponsored by the United Church of Canada.

Issa J. Boullata is Professor of Arabic at the Institute of Islamic Studies, McGill University. His main research interests are centred on Arabic poetry and poetics in both their classical and modern manifestations. Among his publications are Modern Arabic Poets 1950–1975 (1976), the translation of Ahmad Amīn, My Life (1978), and many journal articles.

ADRIAN BROCKETT is Lecturer in Islamic Civilization and Arabic Language in the Department of Modern Arabic Studies, University of Leeds. He has published 'Fragment of a Qur'ān, probably Spanish 15th century', Codices Manuscript, 10 (1984) and The Spoken Arabic of Khābūra on the Oman Bāṭina (Journal of Semitic Studies, monograph 7, 1985). His research interests include oral tradition and the transmission of the Qur'ān as well as teaching Arabic by computer.

FREDERICK M. DENNY has taught at Colby-Sawyer College, Yale, and the University of Virginia, and is currently on the faculty of

Religious Studies at the University of Colorado, Boulder. A specialist in Quranic studies and Islamic ritual, he is at work on a book about the place of the Qur'ān in the lives of Muslims in Egypt and Indonesia, based on field research in the two countries. Among his publications are the college-level text *An Introduction to Islam* (1985) and *The Holy Book in Comparative Perspective* (1985), coedited with Rodney L. Taylor.

ANTHONY H. JOHNS is Professor and Head of the Southeast Asia Centre in the Faculty of Asian Studies at The Australian National University, Canberra. His research is focused on Indonesian Islam as well as the general field of Quranic exegesis, especially Fakhr al-Dīn al-Rāzī, and he has published widely in both fields, with recent articles appearing in *Abr-Nahrain*, *Islamo-christiana*, and the volume edited by A. H. Johns and R. Israeli, *Islam in Asia* (Jerusalem, 1984).

M. J. KISTER is Professor Emeritus of Arabic at the Hebrew University in Jerusalem. He has spent many years researching and writing about traditions on the pre-Islamic tribes, the *sīra* of Muḥammad, and early *ḥadīth* and its compilation. A number of his articles are collected in *Studies in Jāhiliyya and Early Islam* (Variorum, 1980). He has also edited volume 4a of al-Balādhurī, *Ansāb al-ashrāf* and al-Sulamī, *Kitāb ādāb al-suḥba*.

B. TODD LAWSON is Research Director with the Centre for Baha'i Studies, Ottawa. He has studied at the University of British Columbia and McGill University, from where he received his Ph.D. with a dissertation entitled 'The Qur'an commentary of Sayyid 'Alī Muḥammad, the Bāb (1819–1850)'.

FRED LEEMHUIS is Associate Professor of Arabic at Groningen University and has written The D and H Stems in Koranic Arabic: A Comparative Study of the Function and Meaning of the fa"ala and 'af'ala Forms in Koranic Usage (Leiden, 1977) and, together with A. F. J. Klijn and G. J. H. van Gelder, The Arabic Text of the Apocalypse of Baruch: Edited and Translated with a Parallel Translation of the Syriac Text (Leiden, 1986). His major area of research is in philological aspects of early phases of Arabic and other Semitic languages.

JANE DAMMEN MCAULIFFE is Assistant Professor of the History of Religions and Islamic Studies at the Candler School of Theology, Emory University, Atlanta, Georgia. She has published in the areas of Quranic studies and Muslim-Christian relations. Her doctoral dissertation combined these emphases in a study entitled 'Perceptions of the Christians in Qur'ānic tafsīr' (University of Toronto, 1984). She is currently working on the issue of exegetical methodology with particular reference to Fakhr al-Dīn al-Rāzī.

ISMAIL K. POONAWALA is Professor of Arabic and currently Chair, Islamic Studies Program, at the University of California, Los Angeles. His principle publications are al-Sulṭān al-Khaṭṭāb: his Life and Poetry (1967), al-Urjūza al-mukhtāra by al-Qāḍī al-Nu'mān (1970), Biobibliography of Isma'īlī Literature (1977), and The Formation of the State: From the Ḥunayn Expedition to the Prophet's Death, a part of the Ṭabarī Translation project (forthcoming). Presently he is working on Muḥammad 'Izzat Darwaza and his commentary on the Qur'ān.

DAVID S. POWERS is Associate Professor of Arabic and Islamics at Cornell University. He recently published Studies in Qur'ān and hadīth: The Formation of the Islamic Law of Inheritance (University of California Press, 1986). His annotated translation of the years 715 to 724 of al-Tabarī's Ta'rīkh will appear shortly as part of the Tabarī translation project from SUNY Press. At present, he is engaged in research on the practice of Islamic law in medieval Spain and North Africa.

Andrew Rippin is Associate Professor in the Department of Religious Studies, University of Calgary. He has published a number of articles on various aspects of the development of Quranic tafsīr, as well as Textual Sources for the Study of Islam, with J. Knappert (1986). His current research continues to be in the field of commentaries on the Qur'ān, especially those dealing with abrogation.

R. MARSTON SPEIGHT is Co-director of the Office on Christian—Muslim Relations of the National Council of the Churches of Christ and a member of the adjunct faculty of Hartford Seminary, Hartford, Connecticut. Among his publications are *Islam from Within: An Anthology of Texts*, with Kenneth Cragg (Wadsworth, 1980), as well as articles in *The Muslim World* and *Der Islam* on the Qur'ān and *ḥadīth*. He is presently undertaking a rhetorical analysis of *ḥadīth* literature.
