

## Acknowledgments

It is a great pleasure to be able to express my gratitude to the many friends and colleagues who have offered their advice and assistance over the years that I have been working on this book. The parameters of the project, its form, and its argument have evolved a great deal since I first began my research nearly fifteen years ago. However, the initial inspiration for studying the postrevolutionary period remains the same: to understand how ordinary people came to terms with the significance of the French Revolution in its immediate aftermath. I wanted to trace the emergence of new ideas about gender and class, ideas that would remain influential throughout the nineteenth century and well into the twentieth. In the course of my research, I became convinced that everyday life and the dynamics of visibility in urban spaces went a long way in explaining the growing comprehension of ideological constructions relating to the “natures” of men and women and the behavioral expectations of the various classes. Finding evidence for these kinds of quotidian experiences required an ambitious research plan and wide reading across disciplines, and thus I sought advice from a diverse group of scholars, archivists, and librarians.

My first intellectual debt goes to the professors I studied with at the University of Pennsylvania and other institutions. Lynn Hunt was, and continues to be, a model mentor, reading countless drafts without complaint and always listening and offering advice, even when we are thousands of miles apart. Lynn Hollen Lees served as a mentor as well, offering valuable advice on just about every subject imaginable.
