Francesco Antonelli is Research Fellow of Sociology at the University of Roma Tre (Italy). Since 2016 he has been Secretary of the Research Section 'Studi di Genere' (Gender Studies), part of the AIS (Associazione Italiana di Sociologia-Italian Sociological Association). He was Visiting Professor at EHESS (Paris), Universidade de São Paulo (Brazil), Universidade do Minho (Portugal), GESIS Leibniz Institute (Germany), La Trobe University (Australia). He has published a number of books and articles and contributed papers to many conferences.

Marziyeh Bakhshizadeh is a Lecturer with special responsibilities for Social Sciences, Faculty of Society and Economics at the Rhein-Waal University of Applied Sciences (Germany).
