Emina Hasanagic Abuannab is a PhD candidate at the Political Science Department at Bilkent University in Ankara. Her scholarly interests revolve around labour policy, decent work and policy integration, with an emphasis on participatory practices in policy making and participatory policy evaluation methods. In addition to her academic endeavours, Emina works in Monitoring, Evaluation, and Learning in development and humanitarian contexts. Prior to her current pursuits, she garnered experience collaborating with various UN agencies, and humanitarian and development organisations across the Americas, Balkans, Caucasus and Middle East. Katharina Bohnenberger coordinates the research field ‘Social Policy and Environmental Sustainability’ at the German Institute for Interdisciplinary Social Policy Research and is a researcher at the Institute for Socioeconomics at the University of Duisburg-Essen, Germany. She is a founding member of the Sustainable Welfare and Eco-Social Policy Network. Her main research areas are socio-ecological transformation, welfare states and socio-political interest groups as change agents, sufficiency strategies, ecological social policy, eco-social risks and eco-social policy.

Paul Bridgen is Associate Professor of Social Policy in the School of Economic, Social and Political Sciences, University of Southampton, UK. He has published extensively on comparative social policy, often with Traute Meyer, with a particular focus on the UK and other liberal systems. His work over recent years has involved collaborations with a range of international scholars to produce publications on the distributive impact of UK environmental taxation, domestic energy efficiency policy and fuel poverty, and the conceptual frameworks used to understand the challenges posed for social policy by the environmental crisis.

Milena Büchs is Professor of Sustainable Welfare at the University of Leeds, UK. Milena’s research focuses on sustainable welfare, social-ecological policy, post-growth economics and just transitions. In 2023 she co-authored ‘Emissions savings from equitable energy demand reduction’, *Nature Energy*, and ‘Barriers and enablers of radical sharing’, *Lancet Planetary Health*. In 2024 she co-authored ‘Sustainable Welfare: Decoupling Welfare from Growth and Prioritising Needs Satisfaction for All’, in L. Eastwood and K. Heron (eds), *De Gruyter Handbook of Degrowth*.

Jeroen Candel is Associate Professor of Food and Agricultural Policy at Wageningen University, the Netherlands. His research focuses on the

question of how governments, from local to international levels, can foster a transition of the food system towards more sustainable outcomes. Alongside his research, he frequently advises political decision makers and is a member of the Dutch Council on Animal Affairs.

Luca Cigna is a political scientist and holds a PhD from the European University Institute in Florence, Italy, and is now a postdoctoral researcher at LUISS University in Rome. His research interests revolve around trade unions and the politics of organised interests against a backdrop of labour market and welfare reforms.

Benedetta Cotta is Assistant Professor in Political Science at the Department of Political Science, Law and International Studies of the University of Padua, Italy. Her research interests include the implementation of environmental policies in the European Union's member states, the environmental attitudes of citizens and leaders, global environmental governance, and the emergence of eco-social policies in the EU.

Kajsa Emilsson is a researcher and senior lecturer at the School of Social Work, Lund University, Sweden. She has a background in political science, sociology and welfare studies. Her research interest lies primarily in the intersection between social policy and the ecological crisis, including studies of public attitudes and protest participation related to sustainable welfare. His work on eco-social movements and policies has been published in *Policy & Society*, *European Policy Analysis*, *Journal of European Public Policy*, *European Journal of Political Research*, *West European*

Politics, European Societies, Governance, Journal of European Social Policy, Journal of Social Policy, Social Policy & Administration.

Dimitri Gugushvili is Senior Researcher at the Centre for Sociological Research at KU Leuven, Belgium. His current research focuses on comparative analysis of public attitudes towards environmental and social policies, development of post-communist welfare states and redistributional effects of universal versus means-tested welfare provision. His work has been published in multiple academic journals, including *Environmental Sociology, Social Policy and Society, Global Social Policy* and *International Journal of Comparative Sociology*.

Miriam Hartlapp is Professor for Comparative Politics: Germany and France at the Freie Universität Berlin. Her research and teaching focus on European integration and comparative politics. She is particularly interested in questions of polarisation and conflict in the EU Multilevel System, the intersection of economic and social policy, as well as (unequal) representation in political institutions. Together with David Levi-Faur she leads the DFG-funded project ‘Varieties of Procurement Regimes: How Do States Procure Strategically and to What Effect?’ (2024–2027).

Daniel Hausknost is Associate Professor at the Institute for Social Change and Sustainability at the Vienna University of Economics and Business. He studied political science and philosophy in Vienna and holds a doctorate from Keele University, UK. He works primarily on questions of the transformability and sustainability of modern democratic systems and the capitalist state.

Jeroen van der Heijden is an honorary professor at the Australian National University, School of Regulation and Global Governance. He specialises in urban climate governance, focusing on climate change solutions for regenerative urban environments, encompassing (beyond) mitigation and (beyond) adaptation strategies.
