I have been indebted to many people during the long period in which this book has been in the making. Foremost among them is Charles C. Gillispie, my unfailing mentor. It is from him that I learned what it means to be a scholar in the humanities, having come from years of training in the natural sciences. He also taught me by example what it means to be a teacher. He always found time, from the book's beginning as a doctoral dissertation in the mid-1970s, to read all the successive versions, to listen to what I had to say, and to provide numerous comments and suggestions on every aspect of writing and publishing a study on a subject very different from that of his own research.
