DR. DAVID J. JEREMY HAS INVESTIGATED VARIOUS ASPECTS OF TEXTILE, business, and church history for more than forty years. He has held research appointments at Princeton University, the Smithsonian Institution, and the London School of Economics. In the early 1970s he was Curator of the Merrimack Valley Textile Museum at North Andover, Massachusetts (now the American Textile History Museum at Lowell, Massachusetts). His Transatlantic Industrial Revolution: The Diffusion of Textile Technologies between Britain and America, 1790–1830s (MIT Press, 1981), based on his PhD (LSE), was awarded the Dexter Prize of the Society for the History of Technology and the John H. Dunning Prize of the American Historical Association. Retiring as Professor of Business History at Manchester Metropolitan University Business School, he was made an emeritus professor in 2004. In retirement he works and writes from his home in the Peak District of Derbyshire, England.

Polly Darnell is currently the Archivist and Librarian at the Shelburne Museum in Shelburne, Vermont. Between 1980 and 1995, she ran the Research Center of the Sheldon Museum in Middlebury, Vermont. She has taught and written about archives and community history and been active in regional and national archival organizations.
