Richard S. Canter received his B.A., M.A., and Ph.D. in anthropology from the University of California, Berkeley. His field research in the Appalachian area of the United States and in Zambia was supported by the National Institutes of Health (National Institute of General Medical Sciences). His major interests are in legal and political anthropology as they relate to local-level and national-level change. He is currently an Assistant Professor of Anthropology and Co-Director of the Law and Society Program at Boston University.

Klaus-Friedrich Koch began his studies in ethnography, psychology, and philosophy at the universities of Bonn and Tübingen. A Fulbright Fellowship brought him to the University of California, Berkeley, where he obtained a B.A. and Ph.D. in anthropology. He did fieldwork in New Guinea and in the South Pacific, where he directed a four-year project involving comparative studies of law in the polyethnic nation of Fiji and in the kingdom of Tonga.

From 1967 to 1974 he taught at Harvard University, where he also spent a year as a Fellow in Law and Anthropology. Following a year's residency as a visiting scholar at the Center for Interdisciplinary Research at Bielefeld University in Germany, he taught at the University of Virginia (1975–76). He is currently an Associate Professor of Anthropology at Northwestern University.
