Expanded indications for antiarrhythmia agent

Tambacor® (flecainide acetate) has been approved for use in preventing paroxysmal supraventricular arrhythmias

in patients with disabling symptoms but without structural heart disease. This indication is in addition to its use in the treatment of documented ventricular arrhythmias.

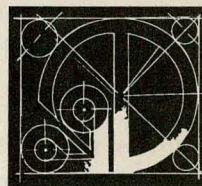
