The journal *Altorientalischen Forschungen* publishes original research on the history and culture of the Ancient Near East as well as exchanges with neighboring regions such as Central Asia, Egypt and the Aegean. Philological and archaeological (including art historical) investigations are equally welcomed. All contributions are peer-reviewed. The journal is published both in print and online.



## **Guidelines for Authors**

Please submit your manuscript in both WORD and PDF format to the editorial office (aof@degruyter.com).

*Illustrations, tables and charts* are submitted separately, with an indication (including captions) of where to place them within the main text. Line drawings must have a resolution of 1000 dpi, photographs ideally 600 dpi, but at least 300 dpi. Please provide appropriate source information for each illustration. The author is responsible for obtaining the required reproduction rights.

Fonts and Orthography: Please use Unicode fonts, preferably Times New Roman. German Language contributions follow the new German orthography according to Duden – Die Rechtschreibung, English language contributions follow the Oxford Style Manual or the Chicago Manual of Style. It is not possible to include footnotes in the title or subtitle.

Each contribution includes an *English abstract* of approximately 80–150 words as well as 3–5 thematic *keywords*. The author's name and affiliation with address and email address is listed at the end of the contribution.

Acknowledgements as well as general information, e.g., particular abbreviations used throughout the text, are not listed in the first footnote, but after the main text and before the bibliography.

Abbreviations of literature generally follow those in the Reallexikon der Assyriologie und Vorderasiatischen Archäologie. You can follow the conventions of the following reference works: Archiv für Orientforschung, Akkadisches Handwörterbuch, Chicago Assyrian Dictionary, Chicago Hittite Dictionary, Keilschriftbibliografie von Orientalia, Hethitisches Wörterbuch<sup>2</sup> or Deutsches Archäologisches Institut. If so, these abbreviations must be listed before the bibliography.

Bibliographical references follow the Author-Date format with bibliography. References within the text include the name of the author(s), followed by year: page number in parentheses, e.g., Güterbock (1973: 235) or Reculeau/Feller (2012: 13). Please quote authors only with family names, and indicate page numbers in full, e.g., 264–285 rather than 264–85. You can use f. for the following page, but not for several following pages (ff.).

In the bibliography, bibliographical referencing follows the formatting of the following examples:

Regarding publications with more than two authors or editors, only the first author/editor is named, followed by et al. Additional information and places of publication are provided in the language in which the contribution is written.

*Proper names*: Place names follow the transliterations of the Tübinger Atlas des Vorderen Orients (TAVO), personal names and names of deities follow general rules of Assyriology/Hittitology (e.g., Reallexikon der Assyriologie und Vorderasiatischen Archäologie). If common/simplified spellings exist, they can be provided in parentheses at the first mention: e.g., Salmānu-ašarēd (Shalmanasser/ Salmanassar).

Transliteration conventions: In the main text, isolated Sumerian words are spaced out, Akkadian and Hittite ones *italicized*. In transliterations of entire texts or text passages, Sumerian is written in regular font, Akkadian and Hittite in *italics*. Sumerograms and pictograms are set in SMALL CAPS, Akkadograms in *ITALICIZED SMALL CAPS*. Superscript determinatives are set in lowercase. Please use only subscript index numbers (Unicode), e.g., a<sub>2</sub> and a<sub>3</sub> rather than á and à.
