



Journal: Informationen Deutsch als Fremdsprache (Info DaF)

Instructions for Authors

Deadlines	You can submit your paper at any time. Accepted papers will be published ahead of print if they cannot be included in one of the next issues.
Topic	We recommend discussing the relevance and appropriateness of your topic with the editorial team before proceeding.
Submission	Please send the manuscript via email to the Managing Editor (kreker@htwg-konstanz.de) or to the editor of the special issue. Please use formats such as docx, doc, or rtf for your manuscript, but not pdf. Please send an anonymized version without your name and biographical details. No special formatting is required for the submitted manuscript.
Review	Info DaF follows a double blind peer review process . Your submission will initially be assessed by the editorial team. If your submission is deemed suitable, it will be sent to two external reviewers.
Length of article	Your manuscript should be between 15,000 and 35,000 characters (including spaces, title, summary and abstract, references, etc.). For contributions to special issues, the length is determined by the editorial team.
Parts of the manuscript	The manuscript, which you submit after the review and acceptance of the contribution, must include the following components: 1. Names of the authors and an email address for the corresponding author. 2. Title in German/title in English 3. Summary in German/ summary in English (up to 500 characters) 4. Three to four keywords in German/ keywords in English 5. Text with illustrations and tables 6. Declaration of generative AI and AI-assisted technologies (if applicable) 7. Reference list 8. Biographical information For the online version, you may provide additional materials.
Declaration of AI	The use of generative AI and AI-assisted technologies must be declared by adding a statement at the end of the manuscript. The statement should be placed in a new section before the references list. An example: • Title of new section: Declaration of generative AI and AI-assisted technologies • Statement: During the preparation of this work the author(s) used [NAME TOOL / SERVICE] in order to [REASON]. After using this tool/service, the author(s) reviewed and edited the content as

	needed and take(s) full responsibility for the content of the published article. The declaration does not apply to the use of basic tools, such as tools used to check grammar, spelling and references. If you have nothing to disclose, you do not need to add a statement.
Layout	Please consider the following guidelines when preparing your manuscript for print: • Use decimal system for section headings, starting with 1 for the introduction; • Avoid hyphenation and formatting; exceptions: emphasized text passages, expressions in other languages, and journal titles (italicize);
Language	Abbreviations (e.g., etc., i.e., and so on) should only be used within brackets or as table headings, but should be spelled out in the text. Exceptions are "etc." and "usw." Use gender-neutral language with neutral formulations ("Studienberatung") and spell out both gender forms (e.g., "Schülerinnen und Schüler" for male and female students). Those who wish to use alternative notations should let us know before the final editing of the manuscript. Only one notation style should be used in the manuscript.
Figures and Tables	Figures (images, drawings, diagrams) may be in color and should be numbered consecutively. Titles should be placed below the figures. Please be mindful of copyright. Tables should also be numbered consecutively. Titles should be placed above the table.
Copyright	Authors are responsible for obtaining the copyright, for instance, for illustrations. Before your manuscript is printed, you will have to sign a Copyright Agreement affirming that you hold the copyright.
Citation Style	If you are using the citation management software "Citavi", you can use the citation style "Informationen Deutsch als Fremdsprache."
References within text	References in the text should be placed within parentheses or in footnotes. Authors should be cited by name in texts for up to three authors. Examples: - wie Müller (1993: 15) sagte, ...; - wir verweisen auf Flügler und Winter (2015: 189-191), die ...; - Baumann, Kammler und Müller (2017) beziehen sich in ihrem Handbuch auf...; - Deygers et al. (2013) sprechen von... (for four or more authors). For in-text citation formatting within parentheses or footnotes: - (vgl. Müller 1993: 15; Flügler/Winter 2015: 189–191); - „...“ - (Koplenig/Müller-Spitzer 2014: 129–130); - „...“ (s. Baumann/Kammler/Müller 2017); - „...“ (Deygers et al. 2013). Please provide complete page ranges instead of using "f." or "ff."
List of References	The references should be compiled into a list at the end of your manuscript. Ensure consistency between the references within the text and the entries in the list of references. Write references in English using lowercase letters. For journal articles: • Marx, Nicole (2018): „Förderung, aber welchen Inhalts? Didaktische Perspektiven auf Bildungssprache im DaF-Unterricht“.
