#### **DESCRIPTION**

Open Information Sciences invites manuscripts for the Topical Issue on Information Behaviour and Information Ethics.

#### Abstract:

This special issue is addressed to the confluence of two lines of research: a) information behaviour and/or information practices and b) information ethics. This includes, but is not limited to, theoretical, empirical and systematic literature review contributions that address issues such as:

- Models of behaviour and ethical decision-making in any context (work, social media, everyday life, ...), raised within any discipline (sociology, psychology, management, ... and based on one or more ethical theories.
- Argumentation on ethical (and/or legal) norms that condition information practices in conflict situations in a professional or organisational setting or in everyday life. Regulation and self-regulation.
- Identification of ethical principles and values in information behaviour and practices interpreted from one or more ethical theories.
- Implications of social, organisational and professional ethics for information behaviour and information practices.
- Description and interpretation of information behaviour and/or information practices from particular cultural perspectives.
- Innovative qualitative or quantitative methodological approaches to the study of information behaviour/information practices from the perspective of information ethics.
- Training of students and information professionals in information behaviour/information practices and ethical decision-making.
- Ethical motivations for the development of research programmes on information behaviour/information practices.

Please select the Category "TI Information Behaviour and Information Ethics" to ensure that the manuscript is processed by the Guest Editors.

It is important that authors include a cover letter with their manuscript. The cover letter should explicitly state that the manuscript (or one with substantially the same content, by any of the authors) has not been previously published in any language anywhere and that it is not under simultaneous consideration or in press by another journal.

Submission of a manuscript does not necessarily imply approval for its publication in this Open Information special issue. The manuscript will be subjected to a peer review procedure managed by our esteemed Guest Editors and its acceptance will depend on this assessment.

There are no specific length restrictions for the overall manuscript or individual sections; however, we urge the authors to present and discuss their findings in a concise and accessible manner. We recommend a length of 5,000-10,000 words, excluding the bibliography and figure captions and a maximum of 15 figures and tables.
